Skater Helmets must conform to SSC Rule D-3 "NO Bicycle helmets are allowed". Helmets must be CSA approved and must be securely fastened under the chin.

Skate Tip Blade Safety: ends must be rounded off with min. of 10 mm. radius in

accordance with ISU rule 291.
