## Skater Equip.:

All skaters are required to wear equipment as outlined by SSC Procedures and Regulations D3-100

- All skaters are required to wear shatter resistant protective sport glasses (clear lenses). Glasses must be held in place by an elastic strap.
- Skaters' helmets must conform to SSC Rule D3-100, "No bicycle helmets are allowed". Helmets must be ASTM F 1849 approved and must be securely fastened under the chin.
- Skate Tip Blade Safety: ends must be rounded off with min. of 10 mm . radius in accordance with ISU rule 291.
- Skaters must wear cut resistant tubes for all competitions/meets and training sessions when NO cut resistant suit is worn. These tubes shall be made of either: Kevlar or Dyneema.
- Shin Protection: skaters must wear hard plastic or built-in cut and puncture resistant material with some impact energy absorption. Foam alone is not sufficient.
